In accordance with the wishes of its founders, the aims of the Fundació Pilar i Joan Miró a Mallorca are to promote and disseminate contemporary creative values, to contribute to the training of young generations of artists, and to encourage them in their commitment to innovation and in genuine research into new channels of creative expression.

It also wishes to promote research into the life and work of Joan Miró and his artistic and cultural milieu, particularly less well-known aspects.

The foundation also wishes to contribute to recognition of Miró's importance as an artist and as a person through educational programmes and projects that bring contemporary art closer to society.

Fundació Miró Mallorca holds the Pilar Juncosa Printmaking Award on a biennial basis, with funding of **€10,000**.

The purpose of the award is to facilitate the creation of a printmaking project in which research and experimentation are fostered into techniques and processes in the field of printmaking and printed series, including all engraving, wood engraving, lithography and screen-printing techniques, the application of new technologies, photography etc.

This edition aims to promote both the winning artist and Joan Miró's printmaking studios, set up by the artist in Son Boter, an 18th century house, to provide further artistic space. Today, the printmaking studios are one of the Foundation's distinctive hallmarks.

The winning project must be created within a maximum of one year from notification of the jury's final decision. It shall be printed in Fundació Miró Mallorca's printmaking studios and the number of copies to be printed shall be agreed upon and divided into two equal parts, one set for the Foundation and one for the artist.

# ENTRY RULES

## DOCUMENTATION

To take part in this edition, the completion of the online entry form on the Foundation's website, [www.miromallorca.com](http://www.miromallorca.com), is absolutely mandatory, and the following documents must be uploaded and sent:

a) The entry form and express acceptance of this edition of the award's entry rules, using the duly completed online form.

b) A photocopy of the entrant's passport or identity card.

In the event of a group entry, a copy of all the entrants' identity cards/passports.

c) The curriculum vitae of the artist or artists (maximum 3 pages). Supporting evidence may be requested.

a) An explanatory account of the intended printmaking project (maximum 5 pages), outlining the characteristics or interest value, background information and reason for its choice, together with a description of the tasks and procedures to be followed, and an approximate study of the materials, tools and equipment that will be needed.

b) A synopsis of a maximum of 10 lines.

The above documentation must be written in Catalan, Spanish or English.

All the required documents must be submitted by the entry deadline, otherwise the applicant will automatically be excluded from this edition.

If entries are submitted with missing documents, they will only be admitted providing that this is rectified by the entry deadline.

Entrants may apply for more than one grant or award. In such an event, they must submit the full documentation for each one.

# DEADLINE FOR ENTRIES

The deadline for the submission of all entries is the **1st of August 2022**.

Once the submitted entry has been registered, the entrant will be sent its registration number by e-mail.

## JURY

Fundació Miró Mallorca shall appoint a competent jury to select the winners. Their decision shall be published on the Foundation's website, [www.miromallorca.com](http://www.miromallorca.com).

The jury reserves the right to declare the award null and void. The jury's members have full capacity and authority to interpret these entry rules.

Only the winning entrants will be informed by e-mail of the jury's decision, and the results shall be published on the Foundation's website and in other means of communication.

The decision shall be announced in October to mark Pilar Juncosa's saint's day and it shall not be open to appeal.

# PAYMENTS

The sum of €10,000 shall be awarded as follows:

A gross sum of €3,000 shall be paid when the award is made.

The remaining €7,000 shall be used as expenses for the printed edition of the winning project. If there is a surplus, it can be used for an exhibition.

The Foundation shall be solely and exclusively responsible for safeguarding, controlling and managing the €7,000 used to create the project.

All necessary expenses for the creation and exhibition, if applicable, of the project must be approved by the Foundation and all invoices accounting for these expenses must be in the Foundation's name, otherwise they will not be paid.

The corresponding withholding tax established in each country shall be applied to the €3,000.

The beneficiary undertakes to mention the support received from Fundació Miró Mallorca in all public dissemination and/or published disclosure of the created work or material.

In the event of non-compliance with the purpose of the award, the award winner shall be obliged to return the money.

# CREATION OF THE PROJECT

The specific dates for the creation of the award-winning project shall be determined in accordance with the Foundation's programme schedule, preferably within one year of the award's notification.

The award-winner may ask for an extension of the time limit, although its acceptance will always depend on the Foundation's internal programme schedule.

The details of the project's creation, conditions, necessary means, work schedule and timing must all be specified sufficiently in advance, taking into account the artist's availability, the programme schedule of the Foundation's studios and a possible timeframe of one year following notification of the award.

The award-winner must work independently on the project to be created. The Foundation must make available the necessary facilities and basic material for its creation, and its technical team shall monitor the process.

Fundació Miró Mallorca reserves the right to the exhibition and dissemination of the artist's work.

Fundació Miró Mallorca offers a research grant worth **€5,000** for projects on the subject of Joan Miró and/or his artistic and cultural milieu.

One of Fundació Miró Mallorca's founder goals is to support and promote research into Joan Miró's life and artistic career, hence contributing to a raised awareness of them.

Projects of particular interest include those aimed at exploring less well-known aspects or periods of Joan Miró's life and work, in addition to the use of information from the Foundation's documentary sources.

The proposed projects must be unpublished on submission of the outlined proposal and they must remain unpublished until the winner or winners have delivered the completed work to Fundació Miró Mallorca. The Foundation's prior written authorization must hence be given for the partial or total dissemination or publication of the work in any form whatsoever prior to the completed version's submission.

The research work for proposals that are awarded a grant must be carried out within a maximum of one year from notification of the Jury's decision.

The Foundation shall appoint a person to monitor the work.

Fundació Miró Mallorca reserves the right to present and possibly publish the final work, always with the author's consent.

50% of the grant shall be paid when it is awarded. The remaining 50% shall be paid the following year for the project's implementation, once the research has been completed and reviewed by the tutor. If it is not approved, the second payment shall not be made.

The corresponding withholding tax established in each country shall be applied to the €5,000.

The beneficiary of the grant undertakes to mention the support received from Fundació Miró Mallorca in all public dissemination and/or published disclosure of the created work.

In the event of non-compliance with the purpose of the grant, the beneficiary shall be obliged to return the money.

## CREATION OF THE PROJECT

The specific dates on which the project is carried out shall be determined in accordance with the Foundation's programme schedule, preferably within one year of the grant's notification.

The beneficiary of the grant may ask for an extension of the time limit, although its acceptance will always depend on the Foundation's internal programme schedule.

The beneficiary of the grant must submit a four-monthly report in Word format, providing an accurate description of how the research is progressing, together with any modifications to the initially proposed project.

The completed project must genuinely contribute to a raised awareness of Joan Miró or his artistic or cultural milieu and it must be academically reasoned, written and presented.

The project proposal and completed research project shall be entered in the Foundation's archives.
